

APPLICATION REQUIREMENTS

Applications for the Judicial Administration Online Masters program are reviewed for Summer, Fall and Spring semester entry. All application material must be received before **February 1** for consideration for the following Summer or Fall semester, and by **September 1** for consideration for the following Spring semester.

Application material includes:

- Application for Graduate Study at Michigan State University
- Official transcripts from all colleges and universities attended
- Official Graduate Record Exam (GRE) scores for exam taken within last 5 years if overall undergraduate GPA is less than 3.2
- Personal statement of academic and professional goals
- Three letters of recommendation
- International students must also submit Test of English as a Foreign Language (TOEFL) scores for exam taken within the last 2 years
